#### 6:04 SELPA Report - Diane Alexander for Dawn Rust

- 1. CNUSD Supporting Inclusive Practices (SIP) SIP training #2 updates regarding expanding co-teaching in the District.
  - 11/2/23 Training held Ramirez Intermediate Danny Dahr, SIP grant.
    - 10 participants attended the focus was on co-teaching pairs to build stronger partnerships around their hopes, attitudes, responsibilities, and expectations.
    - Studied the different co-teaching models and how to determine the best approach based on the learner's needs, lesson objectives, and goals.
    - Participants were asked to commit to 1 co-teaching activity.
  - Next Training: 2/8/24 14 participants signed up to date and hoping to encourage more to attend.
  - Randa asked: How does the district promote attendance to the teachers? Diane will take the question to Kelley G. for follow-up.
- 2. Universal Design Learning (UDL) Update on progress with rolling out UDL.
  - Ginger Pruit met with Katie Novak 2 weeks ago. They are developing a protocol to look at student work for implementation of UDL in the classroom setting.
  - Katie Novak, Ginger Pruit, Kelley G, and 4 principals from <u>Auburndale</u>, <u>Ramirez</u>, <u>River Heights</u>, <u>and CFIS</u> will meet in Zoom in January to plan for a February training to give schools specifically.
  - Katie's coming in February to work with each of the 4 schools (2 days, ½ day at each school site).
  - Teachers will bring student work to the training through our professional learning site.
  - Teachers around the district can sign up for online courses asynchronously.
  - Currently, 29 teachers are signed up and are going through the self-paced course.
- 3. Fair and Accurate Grading Updates
  - Ed Services is working closely with CNTA to ensure that all parts are in place with technology including updates with Parent Q.
  - Parent communication The Ed Services team is collaborating with the Communication team to discuss the upcoming changes.
  - The goal is to begin rolling out communication to elementary parents in February.
    - Plan for a parent guide that will include FAQs and information regarding the shifts in grading.
    - Planning a CNUSD video training discussing the changes that will be shared with the community.

    of the time between the end of the school day and 6 p.m. when kids are getting
    into trouble, mostly violence and drug use. Want to increase after-school
    programs both academics and other activities and extend the program to 6 pm.
    Mystie will look at the impact on special education students so they have equal
    access to these after-school programs.

 Russ Marsh, Principal at Bowers, states there is a reading program with Washington Elementary, working on a 100-mile club with Washington Elementary, a football game with high school football players, cheerleaders, and band members, theater performance at Santiago High School (students at Bowers can intermingle with the performers), attend a choir performance at Norco High in December.

#### 7:20 Coffee Talk
